

Dear Parent(s) /Guardian(s),

You have undoubtedly heard from the news that from Wednesday December 16 all schools, playgroups and childcare locations will be closed for a period up to and including January 17, 2021.

As in the spring, day careshelter will be provided.

The day careshelter is intended for children of parents who both work in a crucial profession. Even if one of you works in a crucial professional group, and you really are unable to arrange childcare for your child, your child may also use the day careshelter. There is no need to provide proof. We assume trust. You may use the day careshelter up to a maximum of the number of hours agreed in the contract you have with us.

Of course it still applies that no use can be made of the day careshelter if there are Corona-related health complaints.

If you want to make use of the day careshelter this week, we ask you to send an email no later than December 16 to the following email address: noodopvang@spa-spo.nl

Please state your name, the name of the child, the name of the out-of-school care center and the days you need day carecare.

In addition to children of parents with crucial professions, there is also the option of day careshelter for vulnerable children. Whether your child is eligible for this depends on the situation. The decision about this will always take place in consultation with an Appropriate Childcare coach or the social district team.

As far as is currently known, the parental contribution will be reimbursed to you by the government at a later stage.

How will day careshelter at our out-of-school care facilities be arranged in the near future?

This week until the Christmas holidays:

This week we follow the schools in the day careshelter. If the day careshelter is at your own school, we also provide day careshelter at your own school on the days that the BSO is normally open. If there is a merger, we will notify you. If you want to make use of the day careshelter, please send a message to noodopvang@spa-spo.nl

Christmas break:

During the Christmas holidays, the out-of-school care centers are only open for the crucial professions and for vulnerable children after referral by coach, social community team or youth consultant. The locations may be merged. Do you want to notify us by Wednesday December 16 whether your child needs day carecare? Then we can determine the locations and inform you about this.

We are open during the Christmas holidays on the days as planned.

After the Christmas holidays 4 to 17 January:

We may then merge a number of locations for the day careshelter.
